

The Connell F. Smith-Homer Brown Scholarship Award is presented to college students whose parents, grandparents, spouse, or who themselves are members in good standing with Laborers' Local 773.

This scholarship is given in honor of the late Local 773 Business Manager /Secretary Treasurer Connell F. Smith whose vision and leadership guides Local 773 today in organizing, political activism and service to the membership. The award also honors the late Homer Brown was a Local 773 Laborer in Cairo, Illinois during the Great Depression and despite his hardships he made certain his 6 children obtained their college degrees to lead productive and successful lives.

Applicants must be enrolled as a full-time student for both FALL&SPRING semesters at an accredited University, College or Vocational School and must maintain at least a 2.6 <u>cumulative</u> GPA during the entire previous year to be considered for the award. Proof of qualifying GPA must be in its official form.

Applicants must have all forms, documents, and essay postmarked no later than April 17th, 2024 in order to be considered for the award. All documentation must be complete and comprehensive. Partial or incomplete applications will be deemed ineligible. **Applications will not be accepted after the March April 17th, 2024 deadline.**

Applications and essays will be reviewed by the committee beginning April 18th, 2024. Eligibility will be conditional upon the submission of Spring 2024/Fall-2024 class schedule. Fall2024 Schedule must be received by July 31, 2024-Spring2024 schedule must be received with the application. (*Excluding High School applicants or those applying for the first time*)

Applicants must reapply each year and supply all documentation in order to become eligible or maintain eligibility. Year to year eligibility is contingent upon meeting all requirements based on the FALL-SPRING enrollment, application, <u>cumulative</u> GPA, essay, volunteer day and most recent transcripts. Recipients who qualified can receive the award for up to 4 years (consecutive or non-consecutive).

Recipients must contribute at least one day of volunteer work **for Laborers' Local 773** during each qualifying year, beginning in April 2024. This volunteer day must be completed before March 2025 in order to reapply. Any applicant who does not participate in a Union volunteer day will be omitted from eligibility**First time applicants will complete a volunteer day during year one of the award and continue to contribute each year of eligibility.

Award Recipients must be in attendance at the 2024 Award Ceremony at to receive their certificate of award. Location and date will be announced at a later date.

CHECK LIST-<u>ALL documents must be submitted in whole and applications must be complete in order to be considered</u> for the award.

• The application must be completed in full including phone number-email and SS#-incomplete applications will be omitted

- High School or College Transcripts from the previous scholastic year must be included at time of application. **IMPORTANT**-the Cumulative GPA for the previous year must be clear and legible on the transcripts. Photos of transcripts or any other form of duplication not originally from the source will not be accepted.
- Proof of admission from accredited college. Acceptance letter first year and/or class schedule thereafter.
- Full Time Student/ 2024 spring schedule included in the application. 2024 Fall Class schedule to be submitted before July 31st.
- Completed Essay. <u>Essay must be complete</u> with 12pt font or less, 2 full pages, single spaced, **min. 1200 word count**. Essays that do not meet the requirements will be omitted from eligibility.
