

## ADDENDUM A (HEAVY / HIGHWAY UTILITY WAGE RATE) SCHEDULE OF WAGES, FRINGES AND DEDUCTIONS LABORERS' LOCAL 773 (MARION, ILLINOIS) and LABORERS' LOCAL 1197 (MCLEANSBORO, ILLINOIS) EFFECTIVE APRIL 1, 2022

<sup>\*</sup>Environmental Work: An additional ten cents (\$.10) per hour training contribution shall be paid by contractors for each hour worked by Laborers that are performing asbestos abatement and removal, hazardous and toxic waste cleanup and removal and lead based paint abatement and removal on jobs identified in the bid documents as environmental projects. \*\*A premium of \$1.00 per hour shall be paid to each employee performing the abovementioned work.

Effective April 1st, 2023 the wage package will increase by \$1.86 per hour with wage placement to be determined.

Effective April 1<sup>st</sup>, 2024 the wage package will increase by \$1.92 per hour with wage placement to be determined.
